
Tavern Spinners and Weavers Guild

November Minutes - Judy moved / Sandi seconded and the minutes were unanimously approved

Reports

Treasurer - Mary Ann advised incoming funds for November were \$1,092.48 of which the guilds shop sales were \$752.65. This amount also included donations of \$188.50. Outgoing funds totaled \$239.31. More information can be found in the treasurer's book in the Yellow Cat Studio.

Foundation – Jan advised the brochure for the Tavern has been completed and is now available to the public for free at the Tavern store front desk.

Golden Village Christmas served 128 children and sales outside of the Tavern store totaled \$3,500.00. In store sales were up 10% over last year.

The foundation annual members meeting will be held on Jan. 24 at 5:30PM and all members are invited to attend.

Studio/Yarn Status – Yarn for beginning weaver's kits has been ordered.

Scholarship – Melinda read the email that went the Middle School Art Teacher, Heather Cockrell. It extended an invitation to Heather to visit our studio. Heather replied via email that she wants to visit and will call to arrange a time and date. Website – Nothing new to report other than a reminder to look at the website periodically to see what Kathy has added; especially pictures from Show and Tell.

Equipment – Our new 8-shaft baby wolf, Wilson, has been cleaned and glued where needed. Wilson was bought from Shirley Wilson and that is how this loom got its name. Tom built a high castle for Selma and it is now installed. Mr. Vinroot brought another box of accessories from Sally Vinroots supplies (hopefully the last), which have now been claimed or discarded.

Old Business

Sale of Sally – A buyer from Pennsylvania has made contact and plans to pick up the 1989 loom Sally on Wednesday, Jan. 11. Judy sent an invoice on Dec. 24, but the buyer said she did not get it. We hope to get a \$500 deposit soon. If you can help with taking Sally apart and helping to load it, please contact Jan or Kathy.

Next Steps Class / Round Robin – for our guild members will be this February 3-5. Please decide on which weaving structure you want to present and teach in the class. It will require you have a 3 yard warp on your loom. For example, Sandi will present overshot placemats, Judy will present twill blocks, etc.

New Business

Northern Neck National Heritage Area - Our Congressman Rob Wittman advised via email that legislation has been passed by the House to declare the Northern Neck Heritage Area Act. Future Projects – We need to display the older rug creations that are in our yarn store room. Also, we should weave more table tops for the café tables that currently do not have a woven cover.
